To: All Landscapers who perform work on properties in the Village of Tarrytown

Landscapers (Green Industry Contractors) who work in the Village of Tarrytown must register pursuant to the Code of the Village of Tarrytown, Chapter 205, Landscaping.

Please complete the enclosed application for your Green Contractor License and return to the Village Clerk together with fees and a copy of the truck registration for each truck that will be operating in the Village of Tarrytown and insurance card for that truck. There is one application that will serve to register your business (\$150) and each of your trucks that you must register (\$25 per truck). Please use the back of the application for additional trucks. Upon completion of registration, you will obtain a "Tarrytown Business" decal for each truck which shall be placed in a conspicuous location on the back of the truck so as to be observable by the eye. The decal will include the expiration date of the license. Landscaping trucks without this decal will not be allowed to operate in the Village.

Please note that the term of the license is from June 1 through May 31 of the following year. Thus, it is important for you to submit your application as soon as possible for processing.
