

The water bill mailing that included the Tarrytown stormwater flyer has been discontinued since last reporting period, due to updating of the system.

The number of storm-water participants has not increased, however it has been discovered that an additional key group (Friends of the Riverfront) is doing clean-ups each month during warm weather at Pierson Park and Scenic Hudson Riverfront, which is where the Village has a series of green infrastructure practices along the Hudson River. This information, in addition to the Tarrytown Lakes Association, should be added to the Tarrytown stormwater flyer for participation potential.
