

## CERTIFICATE OF OCCUPANCY REQUIREMENTS

A CERTIFICATE of OCCUPANCY / CERTIFICATE of COMPLIANCE shall be required for any work which is the subject of a Building Permit and for all structures, buildings, or portions thereof, which are converted from one use or occupancy classification or sub classification to another. Permission to use or occupy a building or structure, or portion thereof, for which a Building Permit was previously issued shall be granted ONLY by issuance of a CERTIFICATE of OCCUPANCY / CERTIFICATE of COMPLIANCE.

The following is a general list of requirements that must be satisfied prior to obtaining a Certificate of Occupancy/Compliance. This list is subject to change based on the occupancy and scope of work outlined in each Building Permit.

- All required inspections have been successfully completed.
- As-built building plans
- As-built survey
- Storm water management installation certification
- Flood hazard certificate
- Electrical underwriters' certificate(s)
- Final plumbing inspection
- Boiler test and inspection certificate
- Fire sprinkler installation and test certification
  - Standpipe pressure test certification
  - Fire pump test certification
- Fire alarm installation and test certification
- Generator start -up test certification
- Elevator installation and test certification
- Energy Star report and certification
- Westchester County Health Department approval
- New York State Department of Transportation approval
- Fire Department inspection
- Professional certifications
- In-Situ Load Tests
