Dear Home Owner/Resident:

The Village of Tarrytown will be updating our On-Street Parking System. Your present on-street parking permit(s) will no longer be valid as of **January 1, 2018**.

We will be issuing new permit(s) which will have an expiration date on them. The permit will be good for one year and will need to be renewed annually. You **MUST** reside on the designated streets (list enclosed). If you replace your vehicle within the year you **MUST** remove the permit or part of and return when obtaining a new permit for the new vehicle.

In order to obtain the new permit, you must complete the enclosed application and attach a **copy of the vehicle registration(s)**. If the address on your registration is not your current address, you must attach a document that has your name and current address.

We will be issuing two guest passes, per household, as we have done in the past. Guest passes will also have an annual expiration date. The resident is responsible for those guest passes. They will **NOT** be re-issued within the valid year. Due to the fact that the Village has received complaints that residents have abused the guest passes for commuters, the Village will be monitoring this situation and may consider revoking improperly used passes.

It is the owner's responsibility to notify any tenants that reside within these permitted areas of the change.
