ADMINISTRATOR'S REPORT

Administrator Slingerland noted that the Village is in the process of clearing the Tarrytown Lakes today and plans to have skating on the lakes by the end of the week or as early as tomorrow. We have inspected the lakes for safety and the ice is 7" thick. It is safe and ready to go. The hours for skating at the Tarrytown Lakes during the week will be 10 a.m. to 5 p.m. and on the weekends, 9 a.m. to 5 p.m. There are no lights on the lakes; therefore, there will be no evening skating. A flag with a green dot, will note that the lakes are open for skating and will be posted every day that skating is allowed. The Village will inspect the ice each morning. When the gate is locked, skating at the lakes will not be allowed. Ice Skating Fees are as follows: Residents 18+ - \$10/season; Residents 17 and under \$5/season; Resident Senior - \$5/season and Non-Residents - \$5/day.

- Skating is at your own risk
- Parents should not drop children off unattended
- We plan to have staff on site to monitor
- There will be no skates to rent
- Benches will be provided to help people change into skates
- Plywood will be put down to protect skates while getting off and on the lake
- Skating buttons will be available to purchase at the Recreation Center and possibly at the lakes site on the weekends.

<u>PUBLIC HEARING – VEHICLES AND TRAFFIC, "OBEY VILLAGE SIGNS" – (adopted)</u>

PLEASE TAKE NOTICE that the Board of Trustees of the Village of Tarrytown will hold a public hearing on the 2nd day of January, 2018, at 8 PM, in the Municipal Building, One Depot Plaza, Tarrytown, New York 10591, to hear, discuss and to act upon a proposed a local law to add a new Chapter 291-3.1 Vehicles and Traffic, "Obey Village Signs" to the Code of the Village of Tarrytown. The complete text of this legislation follows:

A local law to amend Chapter 291. Vehicles and Traffic, Chapter 291-3.1 "Obey Village Signs" of the Code of the Village of Tarrytown to add a new Chapter

Be it enacted by the Village Board of Trustees of the Village of Tarrytown as follows: Section 1: Purpose.

To effectively enforce signs erected by the Village of Tarrytown within the Village. Material to be added is in **bold typeface**.

Chapter 291. Vehicles and Traffic, Chapter 291-2.1. "Obey Village Signs" Every person shall obey the instructions of any official village sign, placed upon any public street and/or highway within the Village or placed upon Village property, unless otherwise directed by a traffic agent or police officer, subject to the exceptions granted the driver of an authorized emergency vehicle as defined in the New York State Vehicle and Traffic Law (Article 1, Section 101).

Section 3: Severability

If the provisions of any article, section, subsection, paragraph, subdivision or clause of this local law shall be judged invalid by a court of competent jurisdiction, such order of judgement shall not affect or invalidate the remainder of any article, section, subsection, paragraph, subdivision or clause of this local law.

Section 4: Effective Date

This local law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law. All interested parties are invited to attend and be heard. Access to the meeting room is available to the elderly and the handicapped. Signing is available for the hearing-impaired; a request must be made to the Village Clerk at least five days in advance of the meeting.

Proposed Action will not have a significant adverse impact on the environment, and hereby adopts a Negative Declaration.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby adopt Local Law No. 1 of 2018.

PUBLIC HEARING - HISTORIC LANDMARK DESIGNATIONS - (adopted)

PLEASE TAKE NOTICE that the Board of Trustees of the Village of Tarrytown will hold a public hearing on the 2nd day of January, 2018, at 8:00 p.m. in the Municipal Building, One Depot Plaza, Tarrytown, New York 10591, to hear, discuss and to act upon a proposed amendments to Chapter 191 entitled "Historic Districts and Landmarks" of the Code of the Village of Tarrytown. A summary of the legislation is available at Village Hall. The complete text of this legislation follows:

A LOCAL LAW to amend Chapter191, Attachment 1 entitled "Village of Tarrytown Historic Landmark Designation" of the Code of the Village of Tarrytown.

SECTION 1. PURPOSE.

The Planning Board, in collaboration with the Historical Society and the Village Historian are reviewing locations throughout the Village for possible designation as historic pursuant to the provisions of Chapter 191 of the Village Code. A local nomination form was completed by the Historical Society for 63 Benedict Avenue, Historic Name: Dr. James D. Sarven House and should be submitted to the Board of Trustees for historic designation. The Board of Trustees has reviewed the nomination form and believes that this location is worthy of designation.

SECTION 2. Amendment to Chapter 191, Attachment 1, "Village of Tarrytown Historic Landmark Designations" of the Code of the Village of Tarrytown.

NEW YORK STATE DEPARTMENT OF TRANSPORTATION LOWER HUDSON TRANSIT LINK (NYSDOT LHTL) ANTENNA AGREEMENT

Trustee McGovern moved, seconded by Trustee McGee, and unanimously carried, that the following resolution be approved: Approved: 4-0

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby authorize and direct the Village Administrator to execute an agreement with New York State Department of Transportation for LHTL antennas that will facilitate traffic flows through telemetrics and tracking of the locations and status of buses in the LHTL system which will improve several intersections around the Village.

AWARD A BID FOR A NEW FIRE RESOURCE AND RESCUE BOAT

Trustee Hoyt moved, seconded by Trustee McGee, and unanimously carried, that the following resolution be approved: Approved: 4-0

WHEREAS, Assemblyman Tom Abinanti and the New NY Bridge Community Benefit Fund helped secure a grant of \$325,000 of state funding for a new fireboat for the Village of Tarrytown. The money was awarded from the State and Municipal Facilities Program (SAM Funds) funded through the state budget; and

WHEREAS, bids were requested to be received by December 20, 2017 for (1) New 36' Fire Resource and Rescue Boat and one bid was received by Metalcraft Marine in the amount of \$360,000; and

WHEREAS, after publication in a regional paper for approximately two weeks, the Village of Tarrytown received one bid on December 20, 2017, and while the physical bid was delivered by UPS next-day-delivery, the package was delayed until the following day because of the volume of holiday deliveries. However, the Village was able to

accommodate their submission by e-mail, which remained unopened until after the bid deadline of 1 p.m., and

WHEREAS, based on language in the bid document that allowed for flexibility so long as it was not prejudicial to other bidders, the Village was able to accept the fire boat bid by email, electronically; and the delayed hard-copy bid was received the next day; and

WHEREAS, the bid itself is for a MetalCraft Marine Interceptor 36 Emergency Fire Rescue and Response Boat that the Fire Department wants, with a bid of \$360,000, and while the original bid submitted by MetalCraft requested progress payments for the Fire Boat, they are willing to comply with the terms of the bid and contract and allow for us to make full payment upon delivery to the Village of Tarrytown.

NOW THEREFORE, BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby award the bid for the Tarrytown Fire Rescue Boat Contract 2017-05 to Metalcraft Marine for the New 36' Fire Resource and Rescue Boat of 690 Riverside Drive, Clayton, New York, and 347 Wellington Street, Kingston, Ontario, per their bid of \$360,000; and

BE IT FURTHER RESOLVED that payment of the boat will be made in a lump sum payment upon delivery of the boat, with \$325,000 funded by the grant, and the balance of \$35,000 funded by operating, appropriation of fund balance, or the future issuance of debt, as determined by the Board of Trustees; and

BE IT FURTHER RESOLVED that the Village Administrator is hereby authorized and directed to execute a contract with Metalcraft Marine for the purchase of the New 36' Fire Resource and Rescue Boat.
