### ADMINISTRATORS REPORT

Administrator Blau reported on the following:

- The 95-gallon garbage cans were delivered to the pilot program addresses today along with a letter explaining the program.
- The paving schedule is a little delayed this year. The paving contractor will be paving in the Village on Wednesday. Only five of the streets scheduled this year will be done now and the rest of the streets will be done in the spring when they return. Beginning this Wednesday, the streets that will be done are Beech Lane, Cobb Lane, Neperan Road (Marymount Avenue to Irving Avenue), Altamont Avenue (Neperan Avenue to Fairview Avenue) and Walden Road (from Beech Lane to the end).

WHEREAS, the Friends of the Tarrytown Lakes plans to facilitate cooperation between the Village and available resources from Federal, State and County agencies as well as environmentally oriented nonprofits; and

WHEREAS, the Board of Trustees believes that there is a tremendous value to the Village for volunteer groups to provide assistance to the Village staff in the ongoing maintenance of the Tarrytown Lakes.

## OPPORTUNITY FOR THE PUBLIC TO ADDRESS THE BOARD. SPEAKERS HAVE FIVE (5) MINUTES BEFORE YIELDING TO THE NEXT SPEAKER; THEN THREE (3) MINUTES FOR ADDITIONAL COMMENTS

Lyle Beehner, 38 Independence Street, stated that today at 9 a.m., he was walking with a baby stroller on the crosswalk at the corner of Broadway and Franklin Street about to cross Franklin Street and was struck by a driver who didn't stop at the stop sign. He noted that he and his children are fine, but the driver never stopped. He feels that many vehicles on Franklin Street do not stop at the stop sign at the corner of Broadway and Franklin Street. Many vehicles tend to just yield and roll through the stop sign to make a right onto Broadway. - Many vehicles also tend to speed up Franklin Street to make a quick right onto Broadway without consideration of the safety of the pedestrians that may be using the crosswalk. In addition, many vehicles speed and cut through Independence Street and Park Avenue with disregard to the stop signs and children in the neighborhood. He asked if speed bumps would be helpful to slow down vehicles and possibly reduce the number of vehicles cutting through Independence Street and Park Avenue.

Mayor Fixell noted that in the past, the Village had considered speed bumps and speed humps in the Independence Street and Park Avenue neighborhood and it had run into obstacles. In order to use speed bumps/humps, it requires posting many signs and there is the issue for snow plows. However, the Mayor noted that we can revisit the speed bumps and/or speed humps again.

Trustee Basher noted that the Village had added (2) stop signs in that area, one at the corner of Park Avenue and Miller Avenue and the other on Riverview Avenue and Glen Avenue.

Trustee Zollo asked Administrator Blau to have the Police Chief study the vehicle traffic at the corner of Franklin Street and Broadway. It might require pedestrian signs to remind vehicles to look to the right and left before proceeding.

Mayor Fixell suggested Mr. Beehner to email the Village Administrator with his concerns with respect to vehicles and traffic in his neighborhood.
