REPORTS

Mayor Fixell noted that the Solarize/Tarrytown program runs to the end of February for residential properties and for commercial properties, it runs a little bit longer. If your property has good exposure to the sun, you should contact Solarize/Tarrytown. There is no obligation. The pricing is excellent and you will save a lot of money.

ADMINISTRATORS REPORT

Administrator Blau reported on the following:

<u>Street Light Replacement Project</u> – The Village Administrator and the Superintendent of Public Works met with the lighting replacement contractor working on the project to convert the Village's streetlights to LED. There are 926 streetlights to be converted in the Village. As of January 22nd, 298 of the 926 streetlights, or 32% of the total, have been converted. The project was moving from the northeast portion of the Village to the southwest portion of the Village.

<u>H-Bridge Painting</u> – At the last Board meeting, Administrator Blau reported on the H-Bridge Painting project and had noted that the contractor had primed the east side of the H-Bridge but I did not know when the contractor would be able to get back to finish the bridge due to weather. I am pleased to report that the weather has cooperated and the painting of the east side of the H-Bridge is complete.
