#### ADMINISTRATORS REPORT

Administrator Blau reported on the following:

- The contractor who is working on the Westchester County Sewer Force Main project on Routes 9 and 119 is coming back to replace the temporary asphalt on the road with rebar and concrete slabs. The work will take place this week and could extend into next week, taking between 5 and 8 days, Monday through Friday from 9 a.m. to 3:30 p.m. In order to do the work on these roads, the traffic will be reduced to one lane. After that, they will be back again to mill and pave the roads.
- Administrator Blau is pleased to report, after 8 ½ years since the Village received notice that Westchester County awarded the Village a grant for the Loh Park Flood Mitigation Project, the Village has put the project out to bid and the bids are due on March 31, 2017. All easements are in place and the project is finally moving forward.
