Board of Trustees Village of Tarrytown Regular Meeting No. 7 May 18, 2015 8:00 p.m.

PRESENT: Mayor Fixell presiding; Trustees: Basher, Butler, Hoyt, McGee, McGovern and Zollo; Village Treasurer Hart; Village Attorney Silverberg and Village Clerk Booth

The meeting began with the Pledge to the Flag.

#### REPORTS

#### CO-MAYORS FOR THE DAY – Caroline and James Povich

Mayor Fixell noted that tonight we have "Co-Mayors for the Day" – Caroline and James Povich. Mayor Fixell also noted that their dad, Colonel Jim Povich is soon to leave on military service to Europe and he thanked Mr. Povich for his service to our country.

#### PARKING BY THE TRAIN STATION

Mayor Fixell noted that effective June 1, 2015; new multi-space parking meters will be used in the parking lots by the train station. For residents, he noted the following:

- 1) All residents should get a new Recreation Permit (TTR) sticker to allow residents to park in the parking lots by the train station after 2 p.m. at no charge. The permit application is on our website. Send the application and copy of your vehicle registration to Village Hall, Treasurers Office.
- 2) If residents need to park in the parking lots by the train station during commuter hours, there will still be available the discounted \$5.00 daily parking permits that you can obtain at the police department.

For non-resident parking, they will need to use the multi-space parking meters for the day and/or for "Yankee Parking." We will no longer be using the parking service that collected parking fees for "Yankee Parking."

James Povich reported that the annual Memorial Day parade will take place on Monday, May 25<sup>th</sup>. The parade will start at 9 a.m. on Main Street in Tarrytown and the route will head north on Broadway to Beekman Avenue, then west to South Washington Street, then south on South Washington Street to Patriots Park where services will be conducted at the Veteran's monuments.

Trustee McGee reported on the following:

- This Saturday, May 23, the new Farmer's Market is having their grand opening at 9:30 a.m. We are very excited to have the farmers market run by a group of citizens with fresh ideas. She urged everyone to come out and support their hard work.
- The Warner Library is hosting the annual Hall of Fame Essay contest winner presentation for Sleepy Hollow High School juniors on May 28, 2015, at 7 p.m. This event is a collaboration among the Warner Library, the Historical Society, a Writer's Organization and the Villages of Tarrytown and Sleepy Hollow. All are welcome.

#### POLICE APPOINTMENT

WHEREAS, the Board of Trustees of the Village of Tarrytown does hereby establish the position of a third lieutenant in the Tarrytown Police Department; and

WHEREAS, the appointment of a member of the Police Department to the third lieutenants position does not establish a permanent third lieutenants position or establish a precedent in the staffing of the Police Department; and

WHEREAS, the continuation of the position of the third lieutenant in the Police Department will be at the sole discretion of the Board of Trustees.

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby promote John Barbelet to the position of Police Lieutenant effective June 1, 2015 at an annual salary of \$149,191, subject to all civil service rules and regulations.

Sgt. John Barbelet thanked the Mayor and the Board of Trustees for this opportunity to continue to serve the police department and the community in his new capacity. He also thanked the men and women of the Tarrytown Police Department for making the police department a high quality department. However, it does not take an individual to make a good department, it takes a group effort. Drivers: Robert Derivan has been approved as a driver for Riverside Hose Company and Antonio Ibarra, Jr. has been approved as a driver for Utility 61.

#### **HUDSON RIVER VALLEY GREENWAY GRANT**

Trustee Zollo moved, seconded by Trustee McGovern, and unanimously carried, that the following resolution be approved: Approved: 7-0

WHEREAS, the Village of Tarrytown is applying to the Hudson River Valley Greenway for a grant under the Greenway Compact Communities Grant Program for a project entitled Tarrytown Station and Waterfront Transit Oriented Development Plan to be located in the Village of Tarrytown; and

WHEREAS, the grant application requires the applicant municipality to obtain the approval/endorsement of the governing body of the municipality or municipalities in which the project will be located.

NOW, THEREFORE, BE IT RESOLVED that the governing board of the Village of Tarrytown does hereby approve and endorse the application for a grant under the Greenway Compact Communities Grant Program, for a project known as Tarrytown Station and Waterfront Transit Oriented Development Plan located within this community.

#### WESTCHESTER COUNTY PRISONER TRANSPORTATION AGREEMENT

Trustee Hoyt moved, seconded by Trustee McGee, and unanimously carried, that the following resolution be approved: 7-0

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby authorize and direct the Village Administrator to execute an Inter-municipal Agreement (IMA) between the Village and Westchester County regarding reimbursement to the Village of Tarrytown Police Department for prisoner transportation to County jail facilities for the period January 1, 2015 through December 31, 2016.

### SHAFT 10 AND HIGH SERVICE WATER TANK SCADA AND COMMUNICATIONS DESIGN

Trustee McGovern moved, seconded by Trustee Butler, and unanimously carried, that the following resolution be approved: Approved: 7-0

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby authorize and direct the Village Administrator to execute an agreement with Woodard & Curran Engineers P.A.P.C of White Plains, New York, in the amount of \$57,912 to create a SCADA (Supervisory Control and Data Acquisition) system for the Water Department.

#### PLANNING SERVICES – TRAIN STATION STUDY AREA

Trustee McGee moved, seconded by Trustee Butler, and unanimously carried, that the following resolution be approved: Approved: 7-0

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby authorize and direct the Village Administrator to execute an agreement with Collaborative Planning Studios per their proposal of \$85,000 to develop an Economic Development Strategy (EDS) as a framework for determining appropriate land use and density for Waterfront Transit Oriented Development (TOD) that benefits both the station area and the Village as a whole.

### <u>AGREEMENT WITH NEW YORK STATE THRUWAY AUTHORITY – WATER LINE</u> IMPROVEMENTS ON ROUTE 9

Trustee McGee moved, seconded by Trustee McGovern, and unanimously carried, that the following resolution be approved: Approved: 7-0

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby authorize and direct the Village Administrator to execute an agreement with the New York State Thruway Authority to share in the cost of the Village's water line improvements on Route 9.

#### MAYOR'S APPOINTMENT OF VILLAGE ATTORNEY

Mayor Fixell appointed Silverberg Zalantis LLP as Village Attorney for a term to expire in April of 2016.
