- 7. Siding "Hardi Board" Cement siding 5" exposure horizontal. Color Deep Ocean (Blue-Gray.)
- 8. Porch floor "AERATIS" composite. Color "Battleship gray.
- 9. Landscape wall "Cambridge" Maytrx series. Color Onyx.
- 10. Railing Cable railing. Supports and top rail Black. Cables Stainless Steel.

TMHA – 50 WHITE STREET

The Board reviewed plans to replace existing facade.

Discussion followed. The Board requested that the applicant return next month with different color schemes.
