The meeting began with the Pledge to the Flag.

REPORTS

Trustee Zollo reported on a positive incident regarding the Tarrytown Police Department. Sergeant Jones received a 911 call from a resident who was suffering from food insecurity and had no money and no food. Sergeant Jones provided the resident with dinner, and helped the resident get in touch with Social Services and also provided information regarding local food banks. Thank you Sergeant Jones for going above and beyond helping our residents. Trustee Zollo reminded residents that there is a local food pantry that takes place on the 2nd, and 4th, Thursday of every month located at Christ Episcopal Church for Tarrytown and Sleepy Hollow residents.

Trustee Brown also reported that if anyone is suffering from food insecurities TASH has vouchers available so families can get fresh organic foods utilizing the vouchers.

Trustee Rinaldi reported that made some changes in front of the old Mrs. Greens. Benches were moved, and plantings were done. In the near future, hopefully a photo exhibit will be done as well.

Trustee McGovern reported on the passing of JP Hill. JP Hill was a premier volunteer person who was always willing to lend a hand, was unselfish and made everyone he met feel so important. This is a great loss for the Village of Tarrytown.

Mayor Butler reported that Congressman Jones paid a visit to Tarrytown. The Mayor and several Trustees met with him and let him know some issues Tarrytown is facing. Mayor Butler also reported that the Westminster Dog Show at Lyndhurst was a complete success. Our hotels were fully booked and the local restaurants and business saw increased sales.

ADMINISTRATORS REPORT

Administrator Slingerland reminded everyone that the first street closure of the year is taking place this Saturday, June 19th from 5:30pm-10:30pm from Broadway to Washington Street. The Board of Trustees has approved twelve dates, but the Board is still working on regulations in regards to authorizing parkettes Chief of Police John Barbelet, Administrator Slingerland, Village Engineer Dan Pennella and Assistant Administrator Josh Ringel

reached out to other communities and the NYS DOT. A report is being compiled and will be available soon. Mayor Butler requested that the report be available in a timely manner so that businesses can make a decision based upon design and cost. Trustee Hoyt mentioned that the Tarrytown Music hall will be reopening this Saturday as well.

BID AWARD H-BRIDGE CONTRACT

WHEREAS, the Village of Tarrytown was the recipient of BRIDGENY Grant to perform repairs to the Village portions of the H – Bridge that lead up and over the Metro North Railroad Tracks in the amount of \$455,461, and

WHEREAS, the Village of Tarrytown published a legal advertisement on May 17th, 2021, and posted the bid on NY Contract Reporter and BidNet, and

WHEREAS, three (3) sealed bids were opened on June 9th, 2021 at 11:00 am at Village Hall with such bids received are listed below:

WHEREAS after review, it is the recommendation of staff and our Consulting Engineer EDG, that the bid be awarded to the lowest responsible bidder McNamee Construction Corp. per their bid of \$379,200.00 for Pin 8761.63 and \$134,200.00 for Pin 8761.64, at the approximate total of \$513,400 (based on unit prices).

NOW THEREFORE, BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby award the bid for the Rehabilitation of the H-Bridge to McNamee Construction Corp. of Lincoln, NY per their bid of \$379,200.00 for Pin 8761.63, and \$134,200.00 for Pin 8761.64, for a total approximate contract value of \$513,400.00 (based on unit prices), and

BE IT FUTHER RESOLVED that the Village’s portion of the contract, covering the cost differential between the grant and project funding project will be funded through existing capital balances or new borrowing, and

BE IT FURTHER RESOLVED that the Village Administrator is hereby authorized and directed to execute a contract with to McNamee Construction Corp. of Lincoln NY., per their bid of \$379,200.00 for Pin 8761.63 and \$134,200.00 Pin 8761.64.
