REGULAR MEETING: 7:00 P.M.

The meeting began with the Pledge to the Flag.

Mayor Brown made a statement on behalf of the Board of Trustees regarding the horrific shooting that took place in Buffalo this past weekend. We stand with them and the entire black community that was targeted by this hateful act of violence. When one community is targeted, we are all targeted. Our Country and this Village stand as one and we must confront hate as one. A moment was silence was then held in honor of the lives lost in the shooting.

BOARD MISCELLANEOUS AND LIAISON REPORTS

Trustee Mitchell reported that there have been some slight changes to the map app. There will be four categories to begin with which include maps of the three Villages, along with restaurant information, hotels and parking availability. We will be meeting with Irvington and Sleepy Hollow in the next few weeks to continue working on the app.

Trustee Rinaldi reminded everyone that the School Board Elections are tomorrow. Currently there are two seats available in Tarrytown with three candidates running.

Deputy Mayor McGovern reported the swimming pool will be opening on May 27th, Pilates is back and the Day and Tot Camp will be starting on June 27th. You can sign up for all classes, programs and camps online. We are also encouraging people to sign up for the fitness center. It's only \$29.00 per month per adult and it's a great deal. Deputy Mayor McGovern also noted that it is National Safe Boating Week. You may receive a free vessel check from the United States Coast Guard Auxiliary at the Tarrytown waterfront this Saturday and Sunday.

Trustee Phillips-Staley reported that on a personal note there has been Con Edison construction work on her street for several weeks and throughout the construction a police officer has been stationed to help with traffic. Each day she gets to meet a new officer and they have been so courteous and helpful. Trustee Phillips-Staley thanked the Tarrytown Police Department.

Trustee Kim reported that there is an open seat on the Transportation and Mobility Council. Interested parties can apply on the Village's website. Additionally, the pollinator gardens that were installed at Sarah Michael's Park look amazing.

Trustee Hoyt welcomed Police Chief Barbelet, Police Sergeant Dennis Smith and Police Lieutenant Barosa and all of the Police Officers to the meeting. The Board of Trustees and the Village Administration support the Tarrytown Police Department. We have been through a lot the last several years and have come through these challenges together. The Village works hard to train, educate and equip the Police Department for the present and the future. Our department consistently remains ahead of other departments in the latest training, educational opportunities, modernizing and diversifying the department including community outreach opportunities. The Village is very proud of the department led by Chief Barbelet. The Board of Trustees will be adopting a resolution this evening recognizing the service of this great department in honor of National Police Appreciation week.

Police Chief Barbelet thanked the Board for having him this evening. In 1962 President Kennedy designated May 15th as Police Officers Memorial Day and included this week as

National Police Week. This week means many different things to many people. As Chief, he embraces the idea that this week is a time to remember those who have made the ultimate sacrifice while working in this profession, and to also honor those who serve and protect their communities every day. Recently this department experienced the sudden loss of an individual who spent more than half of his life doing just what this week is about, serving his community. He was not only a coworker, but a friend. This past year in law enforcement deaths were up 55%. Some was attributed to COVID, but death by firearms was up by 36% in one year. Last year the Tarrytown Police Dept. worked with the Village Board to construct a Police Memorial in front of our department. This signifies on a daily basis what honoring our officer's means. Every day it reminds people of who have served, and those who made it possible. Chief Barbelet continued by stating he was born and raised in this community and came from a family who recognize the importance of public service. Recognition and support come in various forms, and this community has shown both of these attributes on an almost daily basis. This rooms is comprised of many people that support law enforcement. There were times in his career that he wasn't sure if the department would receive the support it deserved and needed. Chief Barbelet stated that this community along with the elected officials here tonight have given him the support he needs to be Chief of Police. Without you, he could not do this. Tarrytown is a great community, and he is proud to serve as Police Chief. The men and women of this department are the best.

Sergeant Dennis Smith spoke on behalf of the PBA. He first asked for a moment of silence in honor of those fallen officers we lost in the past year including our Detective Ojito. Sergeant Smith thanked Administrator Slingerland for his professionalism and patience with his dealings with the PBA. He also thanked supporters of the PBA who go above and beyond which include Michael Rosins from the Bagel Emporium Kevin Johnson from the Sleepy Hollow conference Center, John Stiloski from Stiloski Towing, Glen Voight from the River Market and Robin Warner who was on the police reform committee. This list also includes Frank and Dom Morabito, the Tarrytown Fire Department and Ambulance Corps. At a time when our profession is being constantly scrutinized, we feel that maintaining our working relationship with Village Officials is vital. In closing, Sergeant Smith thanked Police Chief Barbelet who works tirelessly on building bonds with officers and community. He's a good guy and a good Chief.

RESOLUTION FOR NATIONAL POLICE WEEK 2022

On a motion made by Trustee Hoyt, seconded by Deputy Mayor McGovern and unanimously carried, the following resolution was approved. Approved 7-0

Resolution to recognize National Police Week 2022 and to honor the service and sacrifice of those law enforcement officers killed in the line of duty.

WHEREAS, there are more than 800,000 law enforcement officers serving in communities across the United States, including the dedicated members of the Village of Tarrytown;

WHEREAS, since the first recorded death in 1786, more than 23,000 law enforcement officers in the United States have made the ultimate sacrifice and been killed in the line of duty;

WHEREAS, the names of these dedicated public servants are engraved on the walls of the National Law Enforcement Officers Memorial in Washington, DC;

WHEREAS, National Police Week 2022 will be observed from May 15–21, 2022.

BE IT FURTHER RESOLVED THAT, in RECOGNITION OF all fallen officers and their families on May 17, 2022, U.S. flags on Village buildings will be flown at half-staff; AND

BE IT FURTHER RESOLVED THAT the Village publicly thank our police officers for their service to our community and in communities across the nation.

After the resolution was approved, the Board of Trustees read the names of all of the officers currently employed by the Tarrytown Police Department. Administrator Slingerland also stated that he has worked with several police agencies throughout his career and they have all been wonderful to work with, but Tarrytown in particular is an excellent Police Department to work with. There have been some trying times over the past

several years, but from the Chief on down they are all doing a great job and he thanks them for always doing their best.

John Stiloski thanked everyone for recognizing that we have the best Police Department you could ever find. It's a profession, a calling and they are dedicated and very professional. We have one of the best Police Chiefs you could ever find. When promoting an officer, you have a difficult decision because they are all great. There is a lot of false narratives about the police going around in this country especially regarding flags. He wonders what the decision would be if the Board was sitting on the other side of the table, if they would be politically correct to satisfy the undertone of the woke. The quality of life here is great because of our beliefs. He is worried that at a future point someone is thinking to dress them down or softly arm them. Cops don't have a chance to go back to the book or get a second chance. They have to think quickly and make split decisions. God forbid something happens that maybe it looks one way but it's not. That is what worries him.

Tina Bellino stated that a University of Tennessee study stated that morale is an essential contributor to a healthy workplace. It quotes that morale can make a difference between life and death and low morale can cause an officer to be injured or killed. High morale helps with day to day demands. The removal of Detective Ojito's banner must have been a direct blow to the morale of the department. A banner that was hung with permission at WI Boat Club was slashed in half. It simply stated we the people appreciate the Tarrytown Police. It should be investigated as a hate crime. If the Board believes that their actions in the last few weeks doesn't contribute to the blatant disrespect for our police you are sorely mistaken. She submits that this Board publicly denounce the actions of those that would continue the diatribe against our department. Set the right tone that was always present in Tarrytown and contemplate the long term effects your stances have in recruitment of new officers. The Boards policies will have long standing consequences in years to come. She wished to remind the Board that the Police have the highest rate of suicide of any profession in the county. Put politics aside and raise the moral of our department.

Patrick Derivan thanked the Board for honoring the men and women of the Police Department. He wished the youth today would stop and talk to the officers. When he grew up and something happened, we looked towards the police for advice. Our police department shaped the youth in our community. He thanks the Tarrytown Police Department for always being there for him and his family. At times like this we need to keep the moral going.

Kevin from the Sleepy Hollow Conference Center thanked the Chief and his officers. As a business in Tarrytown, he feels that this is the finest police department in the area. We have a good group of officers and we would not be able to operate without them. Thank you for your services and for looking out for us.

George Winsome is a 35 year veteran police officer who is retired. The officers here do a fine job. They were holding a prayer service outside prior to the start of the meeting and Board members just walked by. You should have stopped even for a minute to pay your respects. It sends a bad message. These officers go to work every day wearing bullet proof vests and not one of you have to do that. Show a little respect

Mayor Brown stated that we agree on more than what we want to give each other credit for. She hopes we can all take a step forward in a positive way. She appreciates everyone coming out this evening.

WHEREAS the Village has implemented a permit process for the Pierson Park Picnic Pavilion to streamline the approval of organized activities, provide for appropriate maintenance and staffing when needed, and ensure awareness of and adherence to park rules;

NOW THEREFORE BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown will hold a Public Hearing at the regular meeting of the Board of Trustees on Monday, June 8, 2022 at 7:00 p.m. in the Municipal Building, One Depot Plaza, Tarrytown, New York to consider a local law to amend Chapter 221 of the Tarrytown Code, Section 5 entitled Alcoholic beverages in parks and public areas to allow for the service and consumption of alcohol at events within the Pierson Park picnic pavilion and the picnic pavilion lawn area, provided that a permit has been issued by the Tarrytown Recreation Department.
