WHEREAS, the Board of Trustees has met on March 19, 2018, at 8 p.m., and on April 1, 2019, at 8 p.m., in the Main Meeting Room at Tarrytown Village Hall, 1 Depot Plaza, Tarrytown, NY, on the tentative budget and heard all persons desiring to be heard thereon, and there were no persons who commented on the Tentative Budget; and

WHEREAS, during the budget process, some changes were made to the budget. This includes:

Amend appropriations, and reallocate funds to add a position for Intermediate Clerk to be shared between the Building Department and the Department of Public Works (DPW);

Increase A.5010.101 from \$100,483 to \$120,483 Increase A.3620.101 from \$236,633 to \$266,633 Increase A.9030.800 from \$710,607 to \$714,432 Decrease Contingency from \$314,615 to \$262,388

B. FISCAL YEAR 2019-2020 TAX LEVY AND WARRANT

Trustee McGovern moved, seconded by Trustee Brown, and unanimously carried, that the following resolution be approved: Approved: 7-0

WHEREAS, the budget for the fiscal year commencing June 1, 2019, has been duly adopted and filed with the Village Clerk, and it has been thereby determined that the sum of \$26,272,389 will be necessary to meet the obligations of the Village, and there has been

duly credited against said sum estimated revenues and appropriated fund balance that total \$9,009,123 leaving \$17,263,266 to be raised by the property tax levy; and

WHEREAS, it appears from the Assessment Roll established in 2018 and updated in March, 2019 for taxes for the fiscal year June 1, 2019 through May 31, 2020 that the total assessed valuation of real property in the Village is \$2,140,753,799;

NOW THEREFORE BE IT RESOLVED that the tax rate for the Village of Tarrytown for the fiscal year commencing June 1, 2019 is hereby fixed at the rate of \$8.0641 on each \$1,000 of assessed valuation for properties in the Village of Tarrytown.

BE IT FURTHER RESOLVED that the sum of \$17,263,266 shall be the taxes set for the fiscal year commencing June 1, 2019 and is hereby levied on the taxable property in the Village of Tarrytown and that the Village Treasurer is hereby authorized and directed to extend and carry out upon the roll the amount to be collected from each of the persons named thereon, and the respective amounts of said tax roll against each parcel of taxable property set forth thereon are hereby levied upon each parcel of taxable property respectively which said levy includes items shown on the budget for the fiscal year commencing June 1, 2019.

C. Levy of Additional Taxes upon Termination of Exempt Status:

BE IT RESOLVED that the Town Assessor and Village Receiver of Taxes during the fiscal year beginning June 1, 2019 are authorized to levy and collect additional Village taxes upon termination of exempt status of real property in accordance with provisions of Section 494 of the Real Property Tax Law.

<u>CONTINUATION OF PUBLIC HEARING - LOCAL LANDMARK</u> <u>DESIGNATION, 740 SOUTH BROADWAY (adopted)</u>

PLEASE TAKE NOTICE that the Board of Trustees of the Village of Tarrytown continue a public hearing on the 15th day of April, 2019, at 8:00 p.m. in the Municipal Building, One Depot Plaza, Tarrytown, New York 10591, to hear and consider enacting a local law to create a historic landmark under the Code of the Village of Tarrytown, Chapter 191, entitled "Historic Districts and Landmarks4" for the purpose of designating the property known as 740 South Broadway (S/B/L 1.220-128-28.5) located in the Village of Tarrytown whose record owner is Holy Spirit Association, a historic landmark with Historic Name: Tenant/Farmer House, and direct the Village Administrator and/or the Village Clerk to take the necessary and appropriate actions to circulate the Code-required notices with regard to this proposed designation.

PLEASE TAKE FURTHER NOTICE that the complete text of the legislation is as follows:

A LOCAL LAW to amend the Code of the Village of Tarrytown, Chapter 191 entitled "Historic Districts and Landmarks".

SECTION 1. PURPOSE.

Based upon an investigation of properties within the Village of Tarrytown, the Village Board of Trustees has determined that the property known as 740 South Broadway appears to meet the criteria of Chapter 191 of the Code of the Village of Tarrytown for designation as a Historic Landmark.

SECTION 2: AMENDMENT OF Chapter 191.

- A. Sections 191-7 and 191-8 are hereby renumbered as 191-9 and 191-10 respectively.
- B. A new Section 191-7 shall read:

The Board of Trustees designates the house at 740 S Broadway, not including the garage, as a historic landmark. The Board of Trustees finds and declares that the construction type, materials and methods have distinctive characteristics and historical value to the Village and our region, namely the unique architectural and artistic qualities as well as period vernacular construction means, methods and materials of a tenant/farmer house dating back to the mid-1700s. This includes but is not limited to the attic rafters, floor joists on the first floor, the floor boards on the first floor, as well as the exterior appearance of the house, which includes the two additions that are acknowledged to date. Also, it is important to note that this house may be the last existing structure of its era (estimated 1750) in the Village of Tarrytown.

C. A new Section 191-8 shall read: Reserved.

SECTION 3. EFFECTIVE DATE

This local law shall take effect immediately, as provided by law.

All interested parties are invited to attend and be heard. Access to the meeting room is available to the elderly and the handicapped. Signing is available for the hearing-impaired; a request must be made to the Village Clerk at least five days in advance of the meeting.

BY ORDER OF THE BOARD OF TRUSTEES OF THE VILLAGE OF TARRYTOWN

Trustee McGovern moved, and Trustee Zollo seconded, and unanimously carried (7-0), that the hearing be closed.

Trustee Zollo moved, and Trustee McGovern seconded, and unanimously carried (7-0), that the following resolution be approved:

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby amend the Code of the Village of Tarrytown, Chapter 191, entitled "Historic Landmark Designations" for the purpose of designating 740 South Broadway, Historic Name: Tenant/Farmer House; and

WHEREAS, a public hearing was held for the proposed action on January 22, 2019, February 4, 2019, February 19, 2019, March 4, 2019, March 18, 2019; April 1, 2019 and April 15, 2019; and

WHEREAS, a notice of public hearing was published in the Journal News on January 17, 2019 and April 5, 2019; and

WHEREAS, the Board of Trustees of the Village of Tarrytown is the only agency which has approval authority over the Proposed Action, and is therefore the Lead Agency for the Proposed Action.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

In accordance with Article 8 of the State Environmental Conservation Law and 6NYCRR Part 617, including without limitations the criteria set forth in 6 NYCRR Part 617.7(c) and based upon review of the proposed action and all materials that were prepared for the Proposed Action, the Village Board of Trustees hereby determines that the Proposed Action will not have a significant adverse impact on the environment, and hereby adopts a Negative Declaration.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby adopt Local Law No. 3 of 2019.

<u>CONTINUATION OF PUBLIC HEARING AMENDING THE VILLAGE CODE</u> <u>REGARDING OPERATING BICYCLES ON SIDEWALKS (continued)</u>

Trustee Hoyt moved, and Trustee Zollo seconded, and unanimously carried (7-0), that the hearing be re-opened.

Maria Schmidt, 1 Miller Avenue, noted that she is disappointed that this Board is not supporting the recommendations from the Route 9 plan for bicycling. She would love to see bike lanes in this Village. She is afraid to bike in Tarrytown. If there is no bike lane and there is traffic, she has to bike on the sidewalk; it's the only safest place to be. Right now, Tarrytown is not a safe place to bicycle, but it should be. She would like our Board to be open to the needs of our population that would include biking. She would like the Board to allow biking safely either on a bike lane or a sidewalk.

Mayor Fixell noted that the Board has not rejected the findings of the bike lane task force. The recommendations from that task force are likely to be approved as it is now, which includes a bike lane on Route 9, but not in the downtown area. The Board is not objecting to bicycle on all sidewalks, there are steep hills and narrow sidewalks. The Board is still considering the sidewalks and have not finalized. We have some real issues where we have a very busy downtown and lots of pedestrians and we have to consider their safety. Also, once the bike lane on the bridge is built, we anticipate more bikers coming into town. The Board is not against biking and we are working with the recommendations from the task force. Broadway is a state road, so the state will have to weigh in on the recommendations and ultimately make the decision. The downtown area is a very tight and narrow area and is very built out; it wasn't built in mind with all the people and uses we have today.

Administrator Slingerland noted that we are thinking ahead for when the shared use path opens up on the Cuomo Bridge that could bring in hundreds, if not thousands of bikers coming to Tarrytown. We need to find a balance that will work for everyone.

Daniel Convissor, 26 Maple Street, Sleepy Hollow, stated that he biked to Tarrytown on the sidewalk along Broadway with his 9 year old daughter cautiously to the Music Hall and then went to Main Street Sweets. His friends from Sleepy Hollow who he met up with drove to Tarrytown and used parking spots. It would behoove the Village to get as many people within a 3 mile radius of downtown to bike into town and leave the parking spaces for people who come from a longer distance. The way to keep bikers off of sidewalks is to provide safe streets for cycling. Whether you provide a safe, quiet route on Washington Street, by traffic calming or other techniques and have a connection toward Church Street. Pedestrian safety is his number one concern as well and he hopes that working together can make that happen. While riding to the meeting tonight, he noticed that there is a section of the sidewalk on the H-Bridge that is closed off and there was no alternate provision provided and this seems to be a continual problem within the Village. The Board should take measures with the Building Department to assure that sidewalks are safe for all pedestrians.

Trustee Brown noted the following:

- She was glad to hear that Mr. Convissor offered an alternative bike route that is not on Broadway. She believes that may open ways to work together.
- She asked if he rides his bike at a walking speed, then why not got off the bike and push the bike a few blocks that make up the Broadway downtown.

Mr. Convissor noted that he bikes at a walking speed only when there are people on the sidewalks, and to walk the bike from Cobb Lane to Main Street is a long stretch. He understands the part of Broadway from Central to Main Street should prohibit bicycling on sidewalks, but encourages the Board to leave north of Central on Broadway open to biking on sidewalks. He recommends the Board to provide a protected bike lane on Broadway from the Bridge to Franklin Street, which would create the alternate route to Broadway.

Trustee Hoyt moved, and Trustee Zollo seconded, and unanimously carried (7-0), that the following resolution be approved:

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby continue the public hearing to Wednesday, May 8, 2019, the next regular meeting of the Board of Trustees.

DEROCKER / TARRYTOWN LAND SWAP -- HOME RULE SUPPORT MESSAGE

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Village of Tarrytown does hereby adopt this resolution in support of the Village of Tarrytown Parkland Alienation bill, under Senate Bill number S-5120, and Same as A-7134, introduced by the Village's representatives Senator Andrea Stewart Cousins and Assemblyman Thomas Abinanti; and

BE IT FURTHER RESOLVED that the Board of Trustees of the Village of Tarrytown hereby authorizes the Village Clerk and/or the Village Administrator to take the necessary and appropriate actions to transmit this resolution as a Home Rule Message of Support to the New York State Legislature, to Assemblyman Thomas Abinanti, and Senator Andrea Stewart Cousins, to request them to adopt the legislation to achieve this land swap on behalf of the DeRocker family and the Village of Tarrytown, and thanks our State representatives Senator Stewart Cousins and Assemblyman Thomas Abinanti for their assistance and support to the Village in this matter.
