Board of Trustees Village of Tarrytown Regular Meeting No. 20 September 3, 2019 8:00 p.m.

PRESENT: Mayor Fixell presiding; Trustees: Brown, Hoyt, McGovern and Rinaldi and Zollo; Village Administrator Slingerland; Assistant Village Administrator Ringel; Village Treasurer Hart and Village Attorney Kathy Zalantis and Village Clerk Booth

ABSENT: Trustee Butler

The meeting began with the Pledge to the Flag.

REPORTS

Mayor Fixell noted that there will be a Household Recycling Fall Drop-Off Day on Saturday, September 28^{th} at FDR State Park, Route 202 in Yorktown, from 9 a.m. – 3 p.m. A flyer is on the website with information as to what items are acceptable and not acceptable to recycle. Mayor Fixell's experience with the County's Household Recycling Drop off Day was a very smooth operation and recommends going if you have things to throw out.

Trustee McGovern noted the following:

- The Village Pool will be open this coming weekend, from 10 a.m. 7 p.m. and then will close for the year. She urged everyone to come out and enjoy the last days at the pool.
- The last summer concert is this Thursday, September 5^{th at} 7 p.m., at Patriots Park, presenting "The Bookends." They play music from the 60's and 70's.
- The Tarrytown Village-Wide Tag Sale will take place on Saturday, September 21st from 10 a.m. to 5 p.m., with a rain date of Sunday, September 22nd. The deadline to have your address on the map is Tuesday, September 17th. You can either call the Tarrytown Recreation Department at 914-631-8389 or email your address to <u>ttrec@aol.com</u>.

Trustee Zollo noted that as in years past, the Tarrytown Fire Department will host the 9-11 Ceremony at Patriots Park on Sunday, September 8th at 9 a.m.

Trustee Hoyt noted that schools are now open and he urged everyone to drive carefully and to be mindful of the school buses and crosswalks.

Trustee Brown noted that on Saturday, September 7th, J. P. Doyles in Sleepy Hollow is celebrating their 20th anniversary doing business in Sleepy Hollow. Come out and have some fun.

ADMINISTRATOR'S REPORT

Administrator Slingerland noted the following:

- On Saturday, September 7th from 11:30 1:30 p.m., a Halloween kickoff will take place at Patriots Park as part of the Bicentennial Celebration of the Legend of Sleepy Hollow.
- The developers of Artis, the proposed senior care facility on White Plains Road, which is before the Planning Board, will provide a very brief update at the September 16th Board meeting.
- The Board asked the Village to proceed with the continuation of the Wilson Park Pathway to ultimately meet up with the Tarrytown Trails Pathway. We will be setting up meetings with staff and Mayor Fixell and Trustees Brown and McGovern.
- The Village requested an assessment on the condition of the Tarrytown Lakes and we received an evaluation for where the weeds are heavy in both Lakes. Administrator Slingerland will follow up and request a more precise proposal from them.

- Tomorrow the Village will begin the BioBlast treatment to the Upper Lake. Blue Lake solutions will begin to circulate the organic treatment to the Upper Lake, which is a natural alternative to chemical treatment.
- Next week, the Village will be proceeding with the weeding along the RiverWalk.
- The railing and columns around the Captured Major Andre Memorial Statue are rusting out and would like to consider repairing with high quality and reasonable pricing. The Village would like to focus on this repair as part of the Improvements to the Patriots Park Project.
- The Village has been contacted by residents of Sleepy Hollow Gardens Apartments at 177 White Plains Road about the Post Office's suspension of mail delivery to 4 or 5 sections of the apartment complex due to nuisance dogs, where a carrier has been bitten by a dog. The Village is planning a meeting with Congresswoman Nita Lowey, representatives from the post office and the management company of the apartment complex to see if the Village can get the mail delivery restored. It is difficult for some of the residents to go to the post office to get their mail.
- There was a terrible accident on Main Street on Sunday. An elderly person was attempting to parallel park on Main Street and lost control of his car. His car went up on the sidewalk and jumped across Main Street and hit the 7-11 building. It was remarkable that no one was hurt. Trustee Hoyt noted that along with the Police Department, the Fire Department and Ambulance Corp responded quickly and worked great together. He thanked all three emergency services for their excellent work.

SETTLEMENT OF LITIGATION FOR LAND PURCHASE (NEPERAN ROAD, FORMERLY CITIBANK LOT)

REJECTION OF BID – MODIFICATIONS TO SALT SHED

WHEREAS, the bid was reviewed by the Village Superintendent of Public Works and the Village Engineer and it is the Board of Trustees' recommendation to reject the sole bid and to re-bid the project in the spring, with adjustments in scope and time frame for the work to take place in an effort to solicit additional competitive bids.

NOW THEREFORE, BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby reject the sole bid received for the Modifications to Salt Shed Project.

VEHICLE AND TRAFFIC AMENDMENT (SECTION 291-70 SCHEDULE V: U-TURN PROHIBITIONS)

Trustee McGovern moved, seconded by Trustee Zollo, and unanimously carried, that the following resolution be approved: Approved: 6-0-1

WHEREAS on Main Street (from Broadway to Kaldenberg Place/John Street) is a busy section of roadway with a large amount of vehicular and pedestrian foot traffic. There are

many roadways in the area that motorists can travel on from Main Street that will allow them to go around the block and return to Main Street in the opposite direction, thus removing the need for vehicles to make U-turns. The action of making a U-turn can be dangerous and also impede traffic. The reason for this code amendment is to improve traffic flow and make the area safer for motorists and pedestrians.

NOW THEREFORE, BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby authorize the following code change to Section 291-70 Schedule V: U-Turn Prohibitions: (new language in **bold** print):

Section 291-8 of the Village Code states "No person shall make a U-turn on any of the streets or parts of streets described in Schedule V ($\frac{291-70}{100}$), attached to and made a part of this chapter."

Section 291-70 of the Village Code (Schedule V: U-Turn Prohibitions) describes the name of the streets and locations where U-Turns are prohibited. The following amendment should be made to Section 291-70 (new language in **bold** print);
